Assumption of Risk, Release and Waiver from Liability, Disclaimer and Indemnity

Horse Riding is a dangerous activity.

I understand that Horse Riding is a dangerous activity and that Horses can act in a sudden and unpredictable (changeable) way, especially if frightened or hurt.

I understand and acknowledge that **serious injury** or **death** may result from Horse Riding activities and in particular any of my child's ongoing Horse Riding Lessons.

I agree that my child rides at their, and my, own risk.

I confirm that my child is in good health and has no physical or mental disabilities which could affect their safety whilst on or around Horses.

I acknowledge and agreed that the Director of BDEC, Kristen J McAuslan, and any instructors, assistants or owners and lessees of premises used to conduct activities will not be held responsible or liable for any loss, damage, injury or death to any person or property sustained or occurring whilst attending BDEC.

I hereby release BDEC and anyone associated with BDEC to the full extent permitted by law from all claims and demands of every kind resulting from any **accident, damage or injury** occurring (irrespective of any negligence) and **I expressly agree** that BDEC and anyone associated with BDEC shall have no responsibility or liability for any loss, damage, injury of or death to any person or property sustained or occurring whilst attending BDEC and **I hereby indemnify** BDEC and anyone associated with BDEC against all actions, demands, losses, claims, costs, damages and expenses of whatsoever kind and nature for which BDEC and anyone associated with BDEC shall become liable as a result of my and my child's attendance at BDEC.

I have inspected the Riding Arena and facilities at BDEC and found them to be acceptable and safe and I acknowledge that surface changes can occur (that can effect the Horse's stability) in the Riding Arena that are beyond BDEC's control.

It has been explained to me that due to the reluctance of insurance companies to offer public liability coverage (to high risk activities) that BDEC is unable to obtain or supply any kind of insurance coverage for public liability for BDEC or for any BDEC clients.
